Alan Schneider NYSAP&CSO Scholarships

The NYSAP&CSO Executive Committee is pleased to announce that the annual conference scholarship has been named in honor of retired Suffolk County personnel officer Alan Schneider.

Alan Schneider has been an icon in local Civil Service administration, protecting merit and fitness with skill and grace for 36 years as a personnel officer. Alan has been one of the Association's most respected and active members, as a former Association president (1987-88), a winner of the Merit & Fitness Award (2001), and an advocate for attendance at the annual training conference, regularly bringing the largest delegation. For these reasons, the Executive Committee is pleased to offer the Alan Schneider NYSAP&CSO Scholarship!

Through the Scholarship, funding is available to offset the costs of conference attendance for NYSAP&PCSO members who meet certain eligibility requirements. The purpose of the scholarship is to encourage attendance by agencies that have not recently attended the annual conference so they can experience the value of conference attendance and participation in NYSAP&CSO.

NYSAP&CSO's annual conference offers valuable opportunities to:

- Network with and learn from colleagues and service providers;
- Keep informed of changes in our profession; and
- Meet with and learn from government officials and experts in our profession.

What the Scholarship covers:

Depending on documented need, the scholarship award may cover the expenses related to the conference fee and/or hotel accommodations for an agency that would not be represented at conference without the assistance of the scholarship. The Executive Committee will determine which scholarships will be granted and in what amounts. However, the scholarship can only cover the expense of one hotel room for an agency. An agency may not qualify for a scholarship more than once in a five-year period.

Eligibility:

Eligibility for a scholarship is based on the agency's prior attendance at the annual conference, the agency's available budget, and the membership standing of the applicant. Scholarships will be awarded if the Executive Committee determines that:

- The scholarship will be in the best interests of the Association;
- The agency meets the eligibility requirements; and
- There are sufficient Association funds available to offer scholarships.

Nominations for Scholarship:

The Executive Committee may actively seek potential nominees based on past conference attendance records and information regarding new Personnel Officers and civil service administrators. You can help by keeping in contact with neighboring agencies, encouraging their participation, and informing the Executive Committee if budgetary issues are keeping them from attending the annual conference.

The application deadline for the Alan Schneider NYSAP&CSO Scholarship is March 30th.
