NYSAPCSO is a voluntary professional association which was founded to support the administrators of municipal Civil Service agencies as they strive to fulfill their obligation to uphold the New York State Constitution and enforce the Civil Service Law for the various local government agencies under their jurisdiction.

Every year, the Association may recognize a Civil Service administrator or other government official with responsibility for their jurisdiction's merit system administration who has demonstrated exceptional public service in support of Article V Section 6 of the NYS Constitution and service to NYSAPCSO as a board member or other direct means of support.

### ELIGIBILITY

Awards may be given to:

- Active or recently retired members of NYSAPCSO.
- NYS Officials that have provided direct support to NYSAPCSO.
- Others on the approval of the president/executive committee.

### CRITERIA

With regard to merit system administration, the nominee must have demonstrated:

- An extraordinary achievement resulting in significant efficiencies, benefits or savings to their jurisdiction;
- A record of leadership and accomplishments; and/or
- A long-term commitment to public service exhibiting innovation, creativity and positive change.

With regard to service to NYSAPCSO, the nominee must have demonstrated:

- A record of involvement either on the executive committee or a subcommittee;
- Leadership and participation through the conducting of sessions;
- Dedication to the membership by actions that support the goals of NYSAP&CSO.
